Chairperson Walrafen called the meeting to order at 7:04 pm.

Review Agenda - make any adjustments:

Walrafen suggested adding to Other Business a discussion about working with the new Town Administrative Assistant to have this and future DRB meeting minutes drafted. Volz stated that the Administrative Assistant would use the meeting audio recording to draft minutes rather than attending in-person.

Walrafen suggested adding to the agenda a discussion regarding the DRB search for new members. Volz suggested advertising online on Front Porch Forum.
