Meeting Minutes 16 August 2017

Meeting convened by Sarah at 7:20 p.m., agenda reviewed

Minutes: Minutes from July meeting reviewed, but due to lack of quorum couldn't be officially approved.

Old Home Day: Sarah and Kim will organize a table at the Rec Field to display information about CC projects and provide sign-up sheets for those who want more information. Nicko Rubin will lead a walking tour of Street Trees starting from the Rec Field 1:00-1:30. Rose Paul will conduct an invasives workshop at her house, 2:00-3:00 or 3:30.

Rose Paul (TNC): The Nature Conservancy and the Vermont Natural Resources Council are joined in a statewide effort to remove obsolete dams for the sake of improving aquatic health. This project has financial support from the US Fish and Wildlife Service. The dam in our village (Batchelder Dam) is ranked as high priority for removal, and TNC and VNRC would like to explore the possibility, with the town's consent, of removing this dam. Doing so would open up 110 km of stream (including tributaries to the Winooski) for the benefit of brown and brook trout, a rare mussel, and other aquatic species. Planned removal would also avoid future collapse of the aging dam. Rose will present more information at our September 20 meeting for further discussion.

<u>Town Forest</u>: On our last workday, August 5, even though rain was an issue, good trail clearing was done. We need to relocate the lower trail and repair or replace the puncheon in the wetland. Sarah walked the trails with her, and Sherry was pleased to see the results of their program's support. **Next workday: Saturday, August 26**th.

<u>Current Use Outreach, Street Tree Policy and Long Term Educational Strategy:</u> These two areas of discussion dovetail nicely. Kim, Sarah and Mary are in the process of putting together a combined, focused outreach list which will increase our effectiveness and help us stay clear on tasks and responsibilities.

<u>BioFinder Workshop</u>: The workshop leader, Monica Przyperhart of the VT Fish and Wildlife Department, sent back some dates she could be available this fall: 10/25, 11/1, 11/8 and 12/13. We will decide date at our next meeting, when we hope to have higher attendance.
